#### ACCT 3121—Cost Analysis and Control

**Course Description:** *Prereq: grade of "C" or above in ACCT 3001*. Nature, objectives, basic systems, and procedures of cost accounting and control for manufacturing firms; cost-volume-profit relationships; standard costs and variance analysis; direct costing; relevant costs; activity-based costing.

#### **Textbooks and Other Materials**

Courses that require *paid codes* to access online materials require that special arrangements are made to provide extended material access periods in the event that a course extension is needed. Special ISBN's have been created in these cases. *Do not attempt to order your textbook access codes from other sources.* Students enrolling in ODL courses are *required* to follow the textbook ordering information provided in the syllabus and Getting Started module of the course.



## Nature and Purpose of the Course

**Course Outcomes:** Upon completion of this course, students are expected to be able to:

- Compare and Contrast financial and cost/management accounting
- Demonstrate cost estimation techniques for tracking and monitoring costs
- Identify relevant cost and revenue data and illustrate their use in the decision making process
- Recognize key success factors of cost, effectiveness, efficiency, quality, time and innovation and the impact on organization sustainability.

The underlying premise of this course is the importance of cost accounting in making managerial decisions and its role in the organization's structure.

Cost accounting provides information for both financial and management accounting.

We examine how products are made or services are provided and what resources are required. We discuss the use of accounting information in the development and tracking of cost as well as its use for internal and external performance evaluation.

In this course the terms *cost accounting* and *management accounting* are used interchangeably.

The first six modules introduce new terms commonly used in cost accounting, developing product costs and ways to track these costs. Modules 07 through 12 discuss the uses of the information developed as a means of communication with management and employees for transmitting expectation of objective achievement, performance benchmarks, and decision processes. Finally, Modules 13 through 16 will address special topics that managers commonly face. Additionally, there are three modules that review material from previous modules to aid in your exam preparation.

#### Working with the Course Materials

Remember, this course covers an entire semester of work or the equivalent of a classroom course lasting 15 weeks. That means that each module in this course equals nearly a week of course work and will require the same time and effort on your part. Do not expect to complete each module in a single study session. Understand, too, that if you choose to submit assignments at a very high pace, your instructor may not be able to grade your work at the same rate.

Each module contains information, activities, and assignments organized under a consistent series of headings. Get familiar with how the module is organized. Each module in this course is organized into the following sections: the Module Learning Objectives, the Reading Assignment, Recommend Practice Activities, and the graded MyAccountingLab Module Assignments. You should work through these parts of the module in order. Specific recommendations are provided in a link to the course module instructions, which you should review before beginning the first module.

If you complete the module assignments and work the online assignments, you should be well prepared for examinations. Good grades on the module assignments, however, do not necessarily mean you will achieve good grades on exams. Module assignments are open book, and examinations are closed book with no formula sheets. Keep this in mind as you proceed through the modules and prepare for examinations. Plan to take exams soon after completing the related required modules. Past experience shows that students achieve higher levels of exam success this way rather than completing all modules and then testing.

This course can be mastered through self-paced study. Some find it difficult to gather the self-motivation and inspiration to put in the time that this process requires. Successful performance in this course requires significantly more commitment than you might expect to extend for a normal classroom setting. Extra time spent reading the chapters, accessing the online help tools, and working problems can make the difference between thoroughly understanding a concept and just being familiar with it.

#### Moodle

Always begin by logging in to our Moodle course site. The course is divided into 16 modules. Each module contains an introduction and descriptions of the elements you will need to use on the MyAccountingLab site. It is important to read the Module Material located in the Module Introduction carefully in order to successfully complete your work. Its purpose is to direct you to the proper chapter and give you a brief overview of the material you are about to study. After reading the Moodle introduction, you will utilize study resources and complete your graded assignments in MyAccountingLab. Once you complete your graded practice and homework assignments on the MyAccountingLab site, it is *imperative* that you return to Moodle and verify completion of that module's assignment.

There are also three exam recap modules on the Moodle page. These recaps are made up of pencasts that are designed to assist the student by focusing on particular problem areas and topics covered for their exam preparation..

The course exams will also be administered through Moodle. Please see the "Taking Your Examinations" section of this syllabus for more details on the exam procedures.

## MyAccountingLab

The first time you log on to the Moodle course site, you will need to read the instructions for creating your MyAccountingLab account in the "Getting Started" module. In order to use the course elements in MyAccountingLab, you will need an access code (see instructions for purchasing the code in the "Textbook" section). Most of the course activities, including the online text, tutorials, and graded assignments, are conducted in MyAccountingLab

#### **Reading Assignments**

There are two ways for you to access your reading assignment. You may use the hard copy text or you may read the online version of the textbook on MyAccountingLab. If you are using the online version of the textbook, you will need to reference your Moodle page for specific chapter coverage for reading assignments. In MyAccountingLab your reading assignments for each module are labeled under the "Assignments" tab.

#### **Recommended Activities**

There are several recommended activities in MyAccountingLab to aid in your studying for each module. In MyAccountingLab recommended activities for each module are labeled under the Chapter Resourses tab. There are Interactive Dynamic Study Modules, Excel Simulations, PowerPoint Slides, and Videos allowing you to access your understanding of the material. These resources are *highly recommended as study aids*, but they are not required. They may be viewed unlimited times throughout the course

#### Pre- and Post-chapter Tests

Also contained in MyAccountingLab, are pre- and post-chapter tests that contain a variety of question types for self-assessment in eachmodule. These resources are *highly recommended* for use in studying but not required. They

may be viewed unlimited times throughout the course. These are labeled by chapter number under the Student Resource tab in MyAccountingLab.

### **Graded Homework Assignments**

After studying each module, you are to complete the Graded Practice Problems and Homework Assignments for that module in MyAccountingLab. The assignment is labeled by module number under the Assignment Manager tab in MyAccountingLab. The assignments may include a variety of exercises from each chapter. Your response to each exercise and problem should be wellresearched and completed to the best of your ability. For each Practice exercise, you are allowed three attempts. When each attempt is used, it will reveal the portions of the answer which you completed correctly. You will be allowed to change the incorrect portions on attempts 2 and 3. The third attempt is your final submission. After this attempt, you will see a link that will allow you to view the solution for the problem.

The Graded Homework assignments may be completed in multiple sessions within MyAccountingLab but will only allow one submission attempt. On any exercise, you may save your work without using the only attempt. This is recommended if you spend considerable time on any exercise to avoid a timeout by the website.

Before each exam, you will have an "exam recap" assignment (modules 7, 14, and 23). These modules review key concepts from the previous modules to aid you in your exam preparation.

Once you have completed the graded assignments in MyAccountingLab, return to the appropriate module in Moodle to verify that you have submitted the graded assignment. The assignment will not be entered into the grade book if you do not verify submission in Moodle.

#### Working with the Textbook

Whether you are using the online version or hard copy of the text, it is a good idea to familiarize yourself with the setup of the textbook by looking through it and noting specific features designed to facilitate learning. You will find the following features particularly helpful with this course:

#### **Learning Objectives**

Each chapter is broken down into multiple learning objectives. These are labeled in the margin of the textbook. It is a good idea to note these as you read the chapter and ensure that you are mastering the key concept listed.

#### **End of Chapter Resources**

At the end of each chapter, between the body of the text material and the homework materials, are several features useful for review.

*Problem for Self-Study* gives students another opportunity to see a detailed solution to a representative problem before they do homework assignments.

*Decision Points summarize the chapter's Learning Objectives* by using directed questions.

#### **Suggested Study Techniques**

- 1. Carefully review the module objectives to help you focus on the information that will be covered on the exams.
- 2. Concentrate on the reading assignments, the module lecture material, and any additional resources provided. This review should include a detailed examination of any illustrative problems and examples. After an assignment has been completed, a rapid re-reading of the related text and other materials is strongly recommended.
- 3. Put yourself on a definite schedule. Set aside a certain block of hours per day or week for this course and work in a place where distractions are minimal.
- 4. Try to submit one assignment each week or at least every two weeks. Delays in submitting assignments usually result in lagging interest and the inability to complete the course.
- 5. Review your module assignments after they have been graded, paying special attention to any instructor feedback provided. (We suggest that you wait for assignment feedback before you submit subsequent assignments.)
- 6. Regardless of how you complete your graded assignments, keep in mind that module completion should not be your sole preparation for your exams. As with any college course, you should study for your exams.

## **Reading Assignments**

A detailed reading of each chapter is *strongly urged* in this course. Illustrations are designed to reinforce the concepts presented in the narrative. You should get into the habit of recomputing to each number in the illustrations to assure understanding of how it was derived as well as the connection to other numbers.

There are two ways for you to access your reading assignment. You may use the hard copy text or you may read the online version of the textbook on

#### **Final Examination**

#### Assignments

Each completed module assignment is worth five points. Each completed module assignment will receive a point value. The module assignments are graded in MyAccountingLab. The points for each module are prorated between the exercises in the module assignment. Partial credit is given for all correct parts within an exercise.

Assignment completion is primarily for your benefit and is the key to success in this course. If you have difficulty with any aspect of this course, you may post a question in the forum section for the module.

Take the exams as you proceed in the course and do not wait until after you have submitted all of the modules to begin taking the exams. Taking the exams in the proper order of the course will allow you to receive feedback on your progress before it is too late to make improvements in your study methods if needed.

Carefully study the textbook and recommended activities in MyAccountingLab before you begin to prepare the graded module assignments. This study should include a detailed examination of the illustrative problems and examples, as well as the assigned reading. After an assignment has been completed, a rapid re-reading of the related text and other materials is strongly recommended.

You should submit each module assignment as soon as it is completed. Some courses have restrictions that require that a grade be received before you can submit additional assignments. Specific information on assignment submission is included in the Module Instructions. Please be sure to follow these instructions.

You must have a *grade posted in the Moodle grade book for the Module 16 Assignment in order to unlock access to the Final Exam.* Please allow at least 7 days for the final assignment grade to be posted in the gradebook.

Once you *submit* an assignment, you cannot revise it, so be sure to check your work. Your instructor will normally post a grade for your assignment within *seven calendar days*. Understand that occasional delays will occur, such as during holidays and semester breaks or if you submit several module assignments within the same week. You must have been enrolled in the course for *at least three weeks*, regardless of when the modules and other exams are completed.

Do not rely too heavily on your textbook or other resource material when preparing your assignments. If you do, you may not realize until exam time that the perfect response you prepared for an assignment was only possible

because you referred to resource material without really learning or understanding the material and concepts. Therefore, *you should attempt each assignment without referring to the resource material*, and if you find it necessary to look up an answer, be sure you have actually learned the concept and material rather than merely reflecting it in the answer.

### Academic Integrity

## **Examinations and Grading Policy**

This course includes three multiple-choice exams. Examination I will cover modules 01–06; Examination II will cover modules 07–12; the Final Exam will cover all 16 modules, but will primarily focus on the material in modules 13–16.

Exams I, II, and the Final will consist of 40 questions.

The multiple-choice will include analytical and theory questions as well as problem-solving questions similar to the module assignments. Sufficient preparation should be made prior to attempting each of the examinations. You will have three hours to take each exam. During the examination you will be allowed to use a nonprogrammable calculator.

You are allowed up to three sheets of scratch paper during the exam. To verify the number of sheets and that the paper is blank, you must show your scratch paper to the proctor before you begin your exam. At the end of the exam, the proctor will instruct you to destroy the scratch paper; the proctor must witness you destroying the paper.

You will have a maximum of *three* hours to complete the exam.

# YOU MUST EARN A PASSING AVERAGE ON THE EXAMINATIONS IN ORDER TO PASS THE COURSE.

If you earn a passing average on the exams, your course grade will be calculated as follows:

- Module practice problems are 5 points each. No assignments will be dropped.

- Exams I, II, and Final are 120 points each.
